



Club Affiliation Agreement

Affiliation is important to the development of the sport of pickleball. Pickleball Saskatchewan Inc. (hereby known as Pickleball Saskatchewan) is an affiliate of the Pickleball Canada Organization (hereby known as Pickleball Canada) and recognizes Pickleball Canada as the national governing body. Pickleball Saskatchewan supports the vision, mission and goals of Pickleball Canada.

Becoming an Affiliate Club of Pickleball Saskatchewan, and thereby Pickleball Canada, gives your club a voice in the development of our sport, nationally, provincially and locally. Pickleball Saskatchewan and Pickleball Canada provide strong voices when working with elected officials and government bodies.

Pickleball Saskatchewan is also an affiliate member with Sask Sport Inc. (hereby known as Sask Sport). Through this affiliation our organization receives funding that is made available to its affiliate clubs. It also provides the opportunity to have a voice at the table with over 70 active and affiliate provincial sports organizations.

Criteria for Affiliation

To become a Pickleball Saskatchewan Affiliate,

The _____ Club (now referred to as the Club) agrees to:

1. Recognize Pickleball Saskatchewan provincially, and Pickleball Canada nationally, as the governing bodies of pickleball in Saskatchewan and Canada respectively.
2. Support the vision, mission and goals of Pickleball Saskatchewan and Pickleball Canada.
3. Ensure that all Affiliate Club members are active members in good standing with Pickleball Saskatchewan and Pickleball Canada
4. Have an elected Board of Directors, Executive Committee or structured organization.
5. Have a club bank account.
6. Have a provincially unique, non-misleading club name.
7. Designate one contact person to be the liaison with Pickleball Saskatchewan.

Although Pickleball Saskatchewan may be consulted, the Club has the full right to determine all local matters as long as they do not contravene any of the basic principles of Pickleball Saskatchewan, Pickleball Canada or Sask Sport.
